ON JUNE 20,2006 @ 0029HRS SGT. LEE POWELL, AND OFC. C. HENDERSON RECEIVED A CALL FROM DISPATCH ADVISING OF A FIGHT AT 113 SHARP ST. ONE OF THE SUBJECTS HAD A GUN. WHEN WE ARRIVED WE MET ONE SUBJECT, AND A WHITE FEMALE SUBJECT WALKING ACROSS THE STREET FROM (113 SHARP ST.). WE APPROACHED THE TWO, THEY ADVISED THEY JUST LEFT THE RESIDENCE AND EVERYTHING WAS OK. WE SMELT AN ODER OF ALCOHOL ON THE MALE SUBJECTS(WILLIAM CHIEVES) BODY. WE TOLD SUBJECTS TO GO TO THEIR RESIDENCE(108 SHARP ST.) AND WAIT FOR US. THEN WE NOTICED BLOOD COMING FROM THE MALE SUBJECTS HEAD WE ASKED IF HE NEEDED EMS TO COME AND CHECK HIM, HE ADVISED NO HE WAS OK. THEN HE ADVISED THE OTHER GUY (JUSTIN CHAPMAN) HAD A BLACK COLOR GUN AND HIT HIM WITH IT. THE REASON HE WENT TO JUSTIN'S HOUSE IS BECAUSE JUSTIN WAS GOING AROUND CALLING HIS (WILLIAM) AUNT A CRACKHEAD AND HE DIDN'T LIKE IT. WE WENT TO VICTIM'S (JUSTIN CHAPMAN) RESIDENCE TO TALK WITH HIM. VICTIM (JUSTIN) ADVISED HE, HIS WIFE (CHRISTY HALL,) AND THE TWO WITNESSES(STEPHEN, AND BRANDIE HUGHES) HEARD A LOUD NOISE IT WAS THE BACK WINDOW TO HIS FORD VAN. IT WAS BUSTED OUT THEY SAW THE GUY, AND HIS AUNT WALKING ON THE FROM HIS RESIDENCE BUT DIDN'T SEE THEM BUST ANY WINDOW. THEY WENT OUTSIDE TO ASK THEM WHY THEY BUSTED OUT THE WINDOW. THATS WHEN HE AND THE GUY GOT INTO A FIGHT. THE GUY HIT HIM FIRST AND THEN HE STARTED HITTING THE GUY. HIS WIFE SAID THE SAMETHING, BUT WITNES(STEPHEN HUGHES) ADVISED THE GUY AT FIRST APPROACHED HIM CAUSING PROBLEMS WANTING TO START A FIGHT, BUT WHEN STEPHEN SAID HE WASN'T JUSTIN THATS WHEN THE GUY STARTED ON JUSTIN. THEN THE OTHER PARTY(WILLIAM CHIEVES) CAME TO OUR LOCATION ADVISING HIS GRANDMOTHER JUST FELL DOWN AND HE WAS ASKING US TO CALL EMS. WE FOLLOW THE SUBJECT(WILLIAM CHIEVES) TO 108 SHARP ST. TO CHECK ON HIS GRANDMOTHER. I TOLD DISPATCH TO CALL EMS AND HAVE THEM ENROUTE TO CHECK GRANDMOTHER, AND A JUVENILE THAT LIVES WITH VICTIM SINCE HE WAS HAVNG PROBLEMS BREATHING. WHEN BREMEN FIRE DEPT. ARRIVED THEY CHECKED GRANDMOTHER AND THE JUVENILE. WE CALLED SUBJECT(WILLIAM CHIEVES) OUTSIDE AND EXPLAINED TO HIM HE WAS UNDERARREST FOR ABOVE CHARGES, THEN I PUT HANDCUFFS ON HIM AND ESCORTED HIM TO MY UNIT. SGT.POWELL EXPLAINED TO THE AUNT THE REASON FOR SUBJECT BEING ARRESTED. HE SHOULDN'T HAVE GONE TO VICTIM'S RESIDENCE WHILE INTOXICATED AND CAUSING A FIGHT. (LATE ENTRY WITNESSES, AND WIFE ADVISED JUSTIN DIDN'T HAVE A GUN JUST HIS HANDS.)
